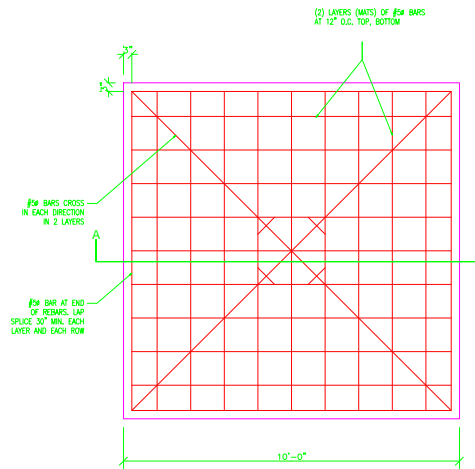


ANTENNA FOOTING - SECTION A-A

- A) CONTRACTOR SHALL FIELD VERIFY ALL DIMENSIONS LOCATING EXISTING CONSTRUCTION BEFORE FABRICATION OF NEW CONSTRUCTION BEGINS.
- B) CONCRETE FOR FOUNDATIONS SHALL DEVELOP A COMPRESSIVE STRENGTH OF AT LEAST 3000 PSI IN 28 DAYS WITH A MAXIMUM SLUMP OF 3" AT TIME OF PLACING.
- C) REINFORCING BARS SHALL CONFORM TO ASTM A 615 GRADE 60 DEFORMED TYPE FY=60000 PSI
- D) PROVIDE 3/4" x 45° CHAMFER ON ALL EXPOSED CONCRETE EDGES
- E) FOUNDATIONS HAVE BEEN DESIGNED TO REST ON UNDISTURBED SOIL WITH A MINIMUM ALLOWABLE NET VERTICAL BEARING CAPACITY OF 2000 PSF. IF UNDESIRABLE SOIL CONDITIONS ARE ENCOUNTERED, THE ENGINEER SHALL BE NOTIFIED BEFORE PROCEEDING WITH CONSTRUCTION.
- F) CONTRACTOR TO FOLLOW ALL RECOMMENDED SPECIFICATIONS BY THE ANTENNA MANUFACTURER FOR PLACEMENT OF FOUNDATION PLATE.
- G) CONTRACTOR TO PROVIDE HI-CHAIRS, VERTICAL BARS, AND/OR #9 WIRE TIES TO ASSURE BARS ARE HELD IN PLACE VERTICALLY AND HORIZONTALLY AS REQUIRED TO PROVIDE 3" COVER ON TOP AND BOTTOM LAYERS.
